Discipline Matrix

| Infraction | Consequence |
|--|--|
| Explosives | Expulsion/Long-Term Suspension; Law Enforcement Notification |
| Bomb Threats / False Alarms | 1st: 5-10 Days Suspension; 2nd: Expulsion/Long-Term Suspension |
| Loitering/Trespassing | 1st: Warning; 2nd: 1-3 Days Detention; 3rd: 1-3 Days Suspension; 4th: 5-9 Days Suspension + CPS Notification |
| Disorderly Conduct - Disruption | 1st: Warning/Detention; 2nd: 1-3 Days Detention |
| Vulgar/Obscene Language or Gestures | 1st: 1-3 Days Detention; 2nd: 3-5 Days Detention; 3rd+: Progressive Suspension to Expulsion |
| Arson/Attempted Arson | 5-10 Days Suspension; Expulsion; Law Enforcement Notification |
| Fighting | 1st: 1-3 Days Suspension; 2nd: 5-10 Days Suspension; 3rd: Expulsion/Long-Term Suspension |
| Threats of Violence | 1st: 1-3 Days Detention; 2nd: 1-3 Days Suspension; 3rd+: Progressive Suspension to Expulsion |
| Insubordination | Progressive: Detention → Suspension → Expulsion |
| Obstructing Investigation | 1st: Warning/Detention; 2nd: 1-3 Days Detention |
| Verbal Abuse of Staff | 1st: 1-3 Days Suspension; 2nd: 5-10 Days Suspension; 3rd: Expulsion |
| Assault of Staff | Immediate Expulsion/Long-Term Suspension |
| Forgery | 1st: Warning; 2nd: 1-3 Days Detention |
| Truancy/Leaving Without Permission | Progressive: Warning → Detention → Suspension → Expulsion |
| Tardiness | 3 Unexcused = 1 Absence |
| Vandalism/Theft < \$50 | 1st: 1-3 Days Suspension + Restitution; 2nd+: Increased Suspension + Restitution |
| Vandalism/Theft ≥ \$50 | 1st: 5 Days Suspension + Restitution; 2nd: Expulsion |
| Endangerment (e.g., firecrackers) | Progressive: Detention → Suspension → Expulsion |
| Extortion | Progressive: Suspension → Expulsion |
| Physical Assault | 1st: 5-10 Days Suspension; 2nd: Expulsion |
| Hazing | Immediate Ban from Extra-Curriculars for the Year |
| Drug/Alcohol Use | Suspension/Long-Term Suspension; Law Enforcement Notified |
| Tobacco Use | Suspension/Long-Term Suspension |
| Sale of Controlled Substances | Immediate Expulsion |
| Under Influence of Substances | Suspension/Long-Term Suspension |
| Sexual Abuse | Expulsion/Long-Term Suspension; Law Enforcement Notification |
| Sexual Harassment | Refer to Policy Section 9.24 |
